#### WHAT THE WARRANTY COVERS

Epp Well Solutions, LLC (“Epp Well”) warrants to the Purchaser of the Epp Well Extension Tank (“tank”) against defects in materials as follows:

- **PARTS:** For a period of three (3) years from the original date of purchase, Epp Well will supply, at no charge, new or remanufactured parts in exchange for Epp Well parts that Epp Well finds are defective, subject to the limitations of this warranty. Epp Well will continue to warrant any defective Epp Well parts found until the end of the warranty period. “Parts” as defined herein includes all system items and components provided by Epp Well. “Parts” may include, but not be limited to such items as water tank(s) or fittings. This limited warranty extends only to Parts that have been furnished by Epp Well.
- **Transferability:** This limited warranty shall be transferable to subsequent owners of the property on which the well is located, but only to the extent that any time remains on the original warranty period.

#### WHAT THE WARRANTY DOES NOT COVER

- This limited warranty **only covers** Epp Well Parts provided and furnished by Epp Well.
- This limited warranty **will be void** if Epp Well Solutions Extension tanks are not installed by a plumber, and **will also be void** if the plumber does not verify their installation by signing and delivering completed forms to Epp Well, and supplying receipts of the installation of the extension tank.
- This limited warranty **will be void** if the Epp Well System was not installed by licensed electricians and certified plumbers in accordance with the Epp Well System Manual, and **will also be void** if the electricians and plumbers do not verify their installations by signing and delivering completed forms to Epp Well, and supplying receipts of installation.
- Any replacement Epp Well Parts must also be installed by licensed electricians and certified plumbers who sign and deliver their completed forms to Epp Well to maintain the limited warranty.
- This limited warranty **does not cover** any product, components, or parts that have subjected to accidents, misuse, neglect, negligence, modification, or other external causes such as weather damage and acts of god.

- This limited warranty **does not cover** any product, parts or components that have been installed or repaired by any unauthorized third parties.
- This limited warranty **is void** if the warranty for the Epp Well Solutions System is voided for any reason.

TO THE EXTENT PERMITTED BY LAW, THE WARRANTY AND REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES AND REMEDIES, AND EPP WELL SPECIFICALLY DISCLAIMS ALL STATUTORY OR IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND AGAINST HIDDEN OR LATENT DEFECTS. IF EPP WELL CANNOT LAWFULLY DISCLAIM STATUTORY OR IMPLIED WARRANTIES, THEN TO THE EXTENT PERMITTED BY LAW, ALL SUCH WARRANTIES SHALL BE LIMITED IN DURATION TO THE DURATION OF THIS EXPRESS LIMITED WARRANTY AND TO REPAIR OR REPLACEMENT SERVICE.

IN NO EVENT, WHETHER AS A RESULT OF BREACH OF WARRANTY OR CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, SHALL EPP WELL BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES.

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.
